**SOFTWARE LICENSE AGREEMENT**

STOP! ANY DOWNLOADING, INSTALLATION, OR USE OF THIS PRODUCT IS NOT PERMITTED UNLESS YOU ACCEPT THE LICENSE BELOW. BY ACCEPTING AND DOWNLOADING, INSTALLING, OR USING THIS PRODUCT INDICATES THAT YOU ARE THE LICENSED USER, THAT ON BEHALF OF YOUR COMPANY ("LICENSED USER"), YOU HAVE READ AND UNDERSTAND THIS LICENSE AGREEMENT, THAT YOU HAVE HAD AN OPPORTUNITY TO CONSULT WITH AN ATTORNEY CONCERNING THIS LICENSE AGREEMENT, AND THAT YOU ACCEPT THE FOLLOWING TERMS. IF YOU REJECT THESE TERMS, THE PRODUCT AND ANY AND ALL RELATED DOCUMENTATION AND PRODUCT KEY MUST BE IMMEDIATELY RETURNED TO THE SHERWIN-WILLIAMS COMPANY ("LICENSOR").

1. Grant and Scope of License.

1.1 Licensed User You are hereby granted a non-exclusive, non-transferable, revocable license to use the Site Survey software and all information therein, including any provided documentation (hereinafter collectively, the "Product"), for the internal business purposes of the Licensed User. Such use shall be limited to employees of the Licensed User and shall not include any use of the Product for or on behalf of others in a consulting or revenue generating context. In addition, although under no obligation to do so, Licensor may from time to time make available for use by the Licensed User updated versions of the Product ("Updates"), on terms and conditions to be determined by Licensor. Upon receipt of any such Update, the Licensed User shall promptly return to Licensor, at the Licensed User's cost, all prior versions of the Product previously delivered to the

Licensed User. The Product may not be pooled or used on any servers without the prior express written consent of Licensor. In addition, the Licensed User acknowledges that Licensor is under no obligation to provide any maintenance or support for the Product, and the provision of any such maintenance or support, if any, shall be under terms and conditions as determined by Licensor, and may be terminated at any time without any liability to Licensor or any of its licensors.

## 2. Proprietary Rights and Obligations.

2.1 This Agreement does not grant to the Licensed User any rights in or to any patents, copyrights, trade names, trade secrets, trademarks, or other intellectual property rights (collectively, the "Intellectual Property Rights") of Licensor or its licensors. The Licensed User shall not make any use of any trademark or trade name of Licensor or its licensors without the prior written consent of Licensor. The Product (including all copies thereof and modifications thereto) and related source code underlying the Product and the Intellectual Property Rights (the "Proprietary Information"), are, and shall remain, the valuable property, and contain the proprietary information, of Licensor and/or its licensors, as applicable. The Proprietary Information shall be maintained by the Licensed User in confidence, shall be disclosed only to its authorized employees having a need to use the Product as permitted by this Agreement, and shall not be disclosed to third parties.

2.2 The Licensed User may not make, have made or permit to be made, any copies of the Product.

2.3 The Proprietary Information constitutes valuable trade secrets of Licensor and its licensors. The Licensed User shall not rent, lease, modify, adapt, translate, reverse engineer, reverse assemble, decrypt, decompile, disassemble or create derivative works based on the Product, merge the Product into any other program, or use all or any portion of the Product for the purpose of deriving its source code, or use all or any portion of the Product for any purpose other than as expressly set forth herein.

### 3. Assignment and Termination.

3.1 The Licensed User shall not sublicense, transfer or assign any of its rights or obligations hereunder or permit the same to be assigned by operation of law, except with Licensor's prior written consent which may be withheld for any or no reason in its sole discretion. An assignment shall be deemed to include, without limitation, a merger of Licensed User with another party, whether or not the Licensed User is the surviving entity, or the acquisition or change in control of more than 25% of the Licensed User's voting stock or assets. Subject to the foregoing, this Agreement shall be binding upon and inure to the benefit of each party's permitted successors and assigns.

3.2 Licensor may terminate this Agreement at any time for any or no reason upon notice to the Licensed User. This Agreement shall terminate automatically without notice upon any of the following: (i) the bankruptcy or insolvency of the Licensed User, (ii) the breach by the Licensed User of any obligation hereunder, and/or (iii) the expiration of the product key provided to the Licensed User. Upon any termination of this Agreement, the Licensed User shall immediately return to Licensor all copies of the Product and related documentation, together with all keys or modifications in any form. Sections 2, 3.2, 4, 5, 6, 7, 8 and 9 hereof shall survive any expiration or termination of this Agreement for any reason.

### 4. No Warranty.

This Product is licensed AS IS WITHOUT WARRANTY OF ANY KIND. In addition, the Licensed User expressly acknowledges that any reports, usage estimates, condition surveys or other surveys (collectively, "Surveys") provided by Licensor to the Licensed User that in any way are derived either from the Licensed User's use of this Product or any information provided by the Licensed User to Licensor in connection with the Licensed User's use of this Product are AS IS WITHOUT WARRANTY OF ANY KIND, The Licensed User assumes all risks and liability associated with the possession and use of the Product and the

Surveys. TO THE EXTENT PERMITTED BY APPLICABLE LAW, LICENSOR SPECIFICALLY DISCLAIMS ALL WARRANTIES, EXPRESS, IMPLIED OR STATUTORY (INCLUDING BUT NOT LIMITED TO ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE OR AGAINST INFRINGEMENT) WITH RESPECT TO THE POSSESSION OF AND USE OF THE PRODUCT AND THE SURVEYS. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, NEITHER LICENSOR NOR ANY OF ITS AFFILIATES NOR ANY OF THEIR RESPECTIVE LICENSORS WARRANT THAT THE PRODUCT WILL OPERATE UNINTERRUPTED OR ERROR FREE. LICENSED USER IS SOLELY RESPONSIBLE FOR THE SELECTION OF THE PRODUCTS TO ACHIEVE LICENSED USER'S INTENDED RESULTS OR FOR LICENSED USER'S PARTICULAR APPLICATIONS. TO THE EXTENT PERMITTED BY APPLICABLE LAW, LICENSED USER SHALL NOT HAVE ANY CLAIM AGAINST LICENSOR, ITS AFFILIATES, ANY OF THEIR RESPECTIVE LICENSORS, OR ANY OF THE FOREGOING'S OFFICERS OR EMPLOYEES OR THE MANUFACTURER OR SUPPLIERS OF THE MEDIA ON WHICH THE PRODUCT RESIDES, WHETHER BASED ON CONTRACT, NEGLIGENCE, PRODUCTS LIABILITY, TRADE PRACTICES, STRICT LIABILITY, FRAUD OR OTHERWISE.

#### 5. Limitation of Liability.

TO THE EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL LICENSOR, ITS AFFILIATES, ANY OF THE FOREGOING'S LICENSORS, OFFICERS OR EMPLOYEES OR THE MANUFACTURER OR SUPPLIER OF THE MEDIA ON WHICH THE PRODUCT RESIDES BE LIABLE FOR ANY DAMAGES WHATSOEVER RELATING TO THE PRODUCT, THE POSSESSION OR USE THEREOF (INCLUDING ANY RESULTS OBTAINED FROM THE USE OF THE PRODUCT, INCLUDING BUT NOT LIMITED TO THE SURVEYS), OR OTHERWISE ARISING OUT OF, RELATED TO OR IN ANY WAY CONNECTED WITH THE PRODUCT OR THIS AGREEMENT,

REGARDLESS OF THE FORM OF ACTION, WHETHER BASED ON CONTRACT, NEGLIGENCE, PRODUCTS LIABILITY, TRADE PRACTICES, STRICT LIABILITY, FRAUD OR OTHERWISE. IN ADDITION, TO THE EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL LICENSOR, ITS AFFILIATES, ANY OF THE FOREGOING'S LICENSORS, OFFICERS OR EMPLOYEES OR THE MANUFACTURER OR SUPPLIERS OF THE MEDIA ON WHICH THE PRODUCT RESIDES BE LIABLE TO LICENSED USER OR ANY OTHER PERSON OR ENTITY FOR ANY DIRECT, COMPENSATORY, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES (INCLUDING BUT NOT LIMITED TO, LOSS OF PROFITS, LOSS OF SAVINGS, LOSS OF DATA OR LOSS OF USE DAMAGES) EVEN IF LICENSOR IS MADE AWARE OF THE POSSIBILITY OF SUCH DAMAGES.

6. General. This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio, without reference to its choice of law rules. Any action brought by the Licensed User against Licensor, under this Agreement or otherwise, shall be brought only in a competent court sitting in the State of Ohio, County of Cuyahoga. The Licensed User hereby consents to the jurisdiction of such court(s) and waives the right to a jury trial in any dispute with Licensor. The Licensed User shall be liable for all costs incurred by Licensor or any of its licensors (including attorneys fees) in connection with (i) the collection of any past due amounts owed by the Licensed User to Licensor whether in connection with this Agreement or otherwise, or (ii) any action in which Licensor is the prevailing party. Licensed user shall pay all applicable sales, use and other taxes along with duties and customs charges imposed on the licensing of the Product. The parties hereto specifically exclude the United Nations Convention on Contracts for the International Sale of Goods from this Agreement, and any transaction that may be implemented in connection with this Agreement.

7. Certain Restrictions.

The Licensed User acknowledges that the laws and regulations of the United States and other jurisdictions restrict the export and re-export of commodities and technical data of United States or other origin, including the Product. The Licensed User agrees to comply with all such restrictions and will not deviate therefrom in any way without the appropriate United States and foreign government licenses.

#### 8. Restricted Rights.

The Product and associated documentation are "commercial items" as such term is defined in 48 C.F.R. 2.101 (October 1995) consisting of "commercial computer software" and "commercial computer software documentation" as such terms are used in 48 C.F.R. 12.212 (September 1995). Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202-1, 227.7202-3 and 227.7202-4 (June 1995), if the Licensed User hereunder is the U.S. Government or any agency or department thereof, the Product and associated documentation are licensed hereunder (i) only as a commercial item, and (ii) with only those rights as are granted to all other end-users pursuant to the terms and conditions of this Agreement.

9. YOU ACKNOWLEDGE THAT YOU ARE AUTHORIZED TO ACCEPT THE TERMS OF THE LICENSE AGREEMENT ON BEHALF OF THE LICENSED USER AND THAT THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE TERMS PURSUANT TO WHICH THE LICENSED USER ACQUIRED THE RIGHT AND LICENSE TO USE THE PRODUCT. THIS AGREEMENT CONTAINS THE ENTIRE AGREEMENT BETWEEN THE PARTIES AND SUPERSEDES ALL PRIOR AND CONTEMPORANEOUS REPRESENTATIONS, PROMISES, STATEMENTS AND UNDERSTANDINGS, WRITTEN OR ORAL, REGARDING THE SUBJECT MATTER HEREOF. THIS AGREEMENT MAY NOT BE MODIFIED OR AMENDED EXCEPT IN A WRITING SIGNED BY BOTH PARTIES. IN NO EVENT SHALL A PURCHASE

ORDER AMEND, MODIFY OR SUPPLEMENT ANY OF THE TERMS OF THIS AGREEMENT.
